Invitation to Apply for Eligibility and to Bid

Renovation of Various BJMP-NHQ Offices-Phase 1

Project Title

General Appropriations Act of 2010

Source of Fund

The **Bureau of Jail Management and Penology (BJMP)**, through the General Appropriations Act of 2010 intends to apply the sum of **One Million Nine Hundred Eighteen Thousand Five Hundred Seventy Nine and 70/100 Pesos (Php 1,918,579.70)** being the Approved Budget for Contract (ABC) to payments under the contract for **Renovation of Various BJMP-NHQ Offices-Phase 1**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

The **BJMP** now calls for the submission of Letters of Intent (LOIs) from potential Bidders to apply for eligibility for the **Renovation of Various BJMP-NHQ Offices-Phase 1**. Bidders should possess a valid PCAB license applicable to the above type and cost of the contract, have completed a similar contract with a value of at least fifty percent (50%) of the ABC, and meet the other minimum eligibility requirements stated in the Eligibility Documents. Interested Bidders must submit their LOIs on or before **5:00 o'clock of July 19, 2010** at **BJMP-NHQ, 144 Mindanao Avenue, Quezon City** and secure the Eligibility Documents therefrom. Applications for eligibility will be evaluated on a "pass/fail" basis. The last day for the submission of the accomplished Eligibility Documents shall be on or before **2:00 o'clock of July 20, 2010** at **BJMP-NHQ, 144 Mindanao Avenue, Quezon City**. Only those Bidders passing the eligibility check will be entitled to purchase the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform

Act,” and is restricted, unless otherwise stated, to organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. In accordance with the IRR-A of R.A 9184, only Bids from eligible Bidders will be opened. In accordance with the IRR-A of R.A. 9184 a contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during post-qualification.

A complete set of Bidding Documents may be purchased by Bidders that passed the eligibility check upon the presentation of the original copy of Notice of Eligibility to the BAC Secretariat, at the address below and upon payment of a nonrefundable fee of **Three Thousand Pesos (Php 3,000.00)**. The Bidding Documents shall be received personally by the bidder or his authorized representative on or before **5:00 o'clock of July 21, 2010**.

The BJMP-NHQ Bids and Awards Committee will hold a Pre-Bid Conference open to all Eligible Bidders on **July 22, 2010 at exactly 2:00 o'clock PM at BJMP-NHQ, 144 Mindanao Avenue, Quezon City**.

Eligible Bidders must submit their Bids at the address below on or before **2:00 o'clock of August 3, 2010**. All Bids must be accompanied by a Bid security in the prescribed form and amount stated under Section 27.2 of the IRR of RA 9184. Late Bids shall not be accepted. Bid opening shall be on **2:00 o'clock PM of August 3, 2010**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.

All works included in this procure shall be completed in ninety (90) calendar days.

The **Bureau of Jail Management and Penology (BJMP)** reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
