INVITATION TO BID FOR

Improvement of BJMPNHQ-Phase V

The **Bureau of Jail Management and Penology (BJMP)**, through the **General Appropriations Act of 2011** intends to apply the sum of **Three Million Two Hundred Eighty-Eight Thousand Two Hundred Thirty and 93/100 Pesos (Php 3,288,230.93)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Improvement of BJMP NHQ-Phase V**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **BJMP** now invites bids for the **Improvement of BJMP NHQ-Phase V** which includes the following scope of works:

- a. Improvement of Directorate for Human Resource Development
- b. Improvement of Directorate for Operations
- c. Improvement of Commission On Audit's Office
- d. Improvement of Directorate for Personnel & Records Management
- e. Improvement of Health Service Office
- f. Improvement of Headquarters Support Service Office
- g. Rewiring of Communication Lines (Telephone, Internet & PA System)
- h. Improvement of Pantry at Fourth Floor

Completion of the works is required for **One Hundred Twenty (120) Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **BJMP-National Headquarters** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 10:00 A.M. on November 16, 2011 to December 5, 2011** respectively.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Seven Thousand Pesos (Php 7,000.00)**.

It may also be downloaded free of charge from the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.


The **BJMP** will hold a Pre-Bid Conference on **November 22, 2011 at 10:00 o'clock A.M. at BJMP Conference Room, BJMP National Headquarters, 144 Mindanao Ave., Quezon City**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **December 5, 2011 at 10:00 A.M. at BJMP Conference Room, BJMP National Headquarters, 144 Mindanao Avenue, Quezon City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Bureau of Jail Management and Penology (BJMP)** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
