BJMP BAC Resolution No. G-2017-012

A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF LOWEST CALCULATED AND RESPOSIVE BID AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF IT EQUIPMENT FOR PROJECT 3 (SINGLE CARPETA SYSTEM ROLL) OF BJMP ISSP; LOT 3: 117 UNITS OF BIOMETRIC SCANNER FOR VISITOR MANAGEMENT

WHEREAS, the BJMP have programmed various IT projects for CY 2016 under the **MITHI** (Medium-Term Information and Communications Technology Harmonization Initiative) an e-Government and ICT support initiative that aims to harmonize and ensure interoperability among ICT-related resources, programs, and projects across the government;

WHEREAS, the BJMPNHQ-BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

WHEREAS, the Invitation to bid (ITB) for the procurement of Biometric Scanner for Visitor under Bid Reference No. G-2017-007 with an **ABC of Php 1,170,000.00** was published at Phil GEPS (Annex "A") and BJMP websites and at the Logistics Bulletin Board (Annex "B") to invite interested bidders to undertake the project, as well as to request the presence of observers and representative from the Commission on Audit and the People Power Volunteers for Reform (Annex "C");

WHEREAS, a pre-bid conference on this project was conducted on March 28, 2017 with the presence of representative/s of the prospective bidders and observers from Commission on Audit and People Power Volunteers for Reform. Said conference yielded positive responses from the prospective bidders and likewise, the TWG of this project have answered various questions and requests for clarifications to address fully the concerns of the prospective bidders on this project;

WHEREAS, submission and opening of bids (Annex "D") was held on April 10, 2017. **Infobahn Communications Inc., Pronet Systems Integrated Network Solutions Inc., Micro Imaging Sales and Services Inc., and Massive Integrated Tech Solutions Inc.- JVA Tekson Computer Sales and Services Inc.** respectively submitted bidding Documents. After the TWG evaluated the eligibility and technical components of the bidders, **Massive Integrated Tech Solutions Inc. - JVA Tekson Computer Sales and Services Inc.,** was declared ineligible for non-submission of a comparative market study or financial proposal of all related IT equipment in the Financial Documents as requirement under ITB Clause no 13.1 (c) of the Bid Data Sheet (BDS). Likewise, **Micro Imaging Sales and Services Inc.,** was also declared ineligible for submitting an unsigned Omnibus Sworn Statement by the authorized representative. Thus, the Chairperson, BAC informed the two ineligible bidders that they are given 3 days to submit their Request for Reconsideration (RR) while their documents remain in the custody of the BAC. The bidders replied that they will file a Request for Reconsideration;

WHEREAS, **Infobahn Communications Inc., and Pronet Systems Integrated Network Solutions Inc.,** passed and complied with all legal and technical components as well as the financial components of this project. Relative thereto, **Pronet Systems Integrated Network Solutions Inc.** was declared the **lowest calculated bidder** for LOT 3 (Supply and Delivery of 117 units of Biometric Scanner for Visitor Management) of the BJMP ISSP; PROJECT 3 (SINGLE CARPETA SYSTEM ROLL) with a bid offer amounting to **Php 700,128.00** and submitted Bid Security in a form of Bid Securing Declaration;

WHEREAS, BAC members, TWG and Secretariat and with the presence of Representatives from Commission on Audit and People Power Volunteers for Reform conducted a meeting on May 25, 2017 (Annex "F") to address and decide on the request for reconsideration filed by Micro Imaging Sales and Services Inc.;

WHEREAS, The TWG recommends to the BAC members (Annex "G") to decline the request of **Micro Imaging Sales and Services Inc.** considering that the purpose of the submission of Omnibus Sworn Statement of the bidder is to certify that each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete and all statements and information provided therein are true and correct in reference to GPPB Non-Policy Opinion dated March 31, 2014 (NPM 009-2014). Hence, the submission of unsigned affidavit is tantamount to not submitting at all;


WHEREAS, the BAC decided to concur with the recommendations of the TWG that the request for reconsideration of **Micro Imaging Sales and Services Inc.** be denied and further advised the TWG to inform the bidder of the decision of the BAC and likewise to proceed to the conduct of detailed bid evaluation on the lowest calculated bidder- **Pronet Systems Network Integrated Solutions Inc.**;

WHEREAS, the TWG conducted Post-qualification process to **Pronet Systems Network Integrated Solutions Inc.** The TWG have found the said bidder to be compliant and have passed all the necessary requirements of this project and was declared as the **lowest calculated and responsive bidder.**

NOW THEREFORE, THE BJMP BAC RESOLVED AS IT IS HEREBY RESOLVED to recommend to the Chief, BJMP to award the procurement of aforementioned project to **Pronet Systems Network Integrated Solutions Inc.** in the total amount of **Seven Hundred Thousand One Hundred Twenty-Eight Pesos (Php 700,128.00).**


