A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BIDDER AND AWARD OF CONTRACT TO DIAMOND MOTOR CORPORATION FOR THE SUPPLY AND DELIVERY OF VARIOUS PRISONER'S VAN (LOT 1 – Supply and Delivery of 50 units, Prisoner's Van with Single Air Conditioner and LOT 2 - Supply and Delivery of 250 Units Prisoner's Van)

WHEREAS, the Bureau of Jail Management and Penology published its Invitation to Bid (ITB) on the Supply and Delivery of Various Prisoner's Van at the PhilGEPS on November 30, 2017 with BJMP IB No. G-2017-40, likewise posted at the BJMP National Headquarters Bulletin Board and was also published on a newspaper with nationwide circulation with an Approved Budget for the Contract (ABC) amounting to Two Hundred Seventy Seven Million

Five Hundred Thousand Pesos (Php277,500,000.00), to wit:

WHEREAS, a Pre-Bid Conference was held on December 8, 2017, 10:00 a.m. at the BJMP NHQ Conference Room, 144 Mindanao Avenue, Project 8, Quezon City;

WHEREAS, the Opening of Bids was held on December 20, 2017, 10:00 a.m. at the same address stated in the preceding paragraph. The Bid Opening was attended by members of the BAC, BAC Secretariat and BAC TWG, with the presence of the following bidders: (1) MCX International, Inc.; and (2) Diamond Motor Corporation;

WHEREAS, despite sending invitation letters to the Observers, the Commission on Audit (COA), the People Power Volunteer for Reforms (PPVR) and the Philippine Chamber of Commerce and Industries (PCCI) to witness the opening of bids, they were not able to send their representatives;

WHEREAS, based on a non-discretionary pass-fail eligibility criteria, below is the

**WHEREAS**, on December 28, 2017, the opening of financial documents for the supply and delivery of various prisoner's van resumed;

WHEREAS, upon careful examination, validation and verification of all the eligibility/technical and financial requirements and based on the result of Test Parameters for the prototype prisoner's vans for Lot 1 and Lot 2, Diamond Motor Corporation, being the Single Calculated Bidder was found to be responsive thus post-qualified;

**NOW THEREFORE,** in view of the forgoing premises, We, the Members of the BJMP-NHQ Bids and Awards Committee **RESOLVE, AS IT IS HEREBY RESOLVED** to recommend to the Chief, BJMP, the following:

- 2. To recommend that the Supply and Delivery of Various Prisoner's Van (Lot 1 - Supply and Delivery of 50 units, Prisoner's Van with Single Air Conditioner) be AWARDED to Diamond Motor Corporation in the amount of Php47,795,965.00;
- 3. To recommend that the Supply and Delivery of Various Prisoner's Van (Lot 2 – Supply and Delivery of 250 units, Prisoner's Van) be AWARDED to Diamond Motor Corporation in the amount of Php229,653,997.50.
