## **BIDS AND AWARDS COMMITTEE** Resolution No. G-2018-006

A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 71 UNITS OF HANDHELD RADIO CY 2018 TO MICRODATA SYSTEMS AND MANAGEMENT, INC.

WHEREAS, the Bureau of Jail Management and Penology advertised the Invitation for the Bidding of "Supply and Delivery of 71 units of Handheld Radio" at PhilGEPS on February 28, 2018 with ITB Ref. No. G-2018-007 for CY 2018, with an Approved Budget for the Contract (ABC) amounting to Three Million Five Hundred Fifty Thousand Pesos (Php3,550,000.00);

WHEREAS, a Pre-Bid Conference was conducted on March 8, 2018 with the presence of BAC Members, BAC Secretariat, BAC-TWG, and attended by PPVR Representative as observer;

WHEREAS, the Opening of Bids was held on March 20, 2018 at 11:30 a.m. at the BJMP Main Conference Room, 4/F BJMP National Headquarters with the presence of Microdata Systems and Management Inc. being the lone bidder;

WHEREAS, during the bid opening, Microdata Systems and Management Inc. passed the non-discretionary pass-fail eligibility criteria and was thus declared eligible;

WHEREAS, below is the result of the opening and evaluation of its financial proposal:

WHEREAS, on April 16, 2018, the BAC through its Technical Working Group conducted its post-qualification process and upon careful examination, validation and verification of all the legal, technical and financial requirements submitted by Microdata Systems and Management Inc. being the Single Calculated Bidder, was found to be responsive, thus, post-qualified;

NOW THEREFORE, the BJMP Bids and Awards Committee RESOLVES, AS IT IS HEREBY RESOLVED to recommend to the Chief, BJMP the following:

1. To declare Microdata Systems and Management Inc. as the bidder with the Single Calculated and Responsive Bid; and

2. To recommend that the project "Supply and Delivery of 71 units of Handheld Radio" be awarded to Microdata Systems and Management Inc. with a bid amount of Three Million Five Hundred Forty Eight Thousand Nine Hundred Thirty Five didic Pesos (Php3,548,935.00).
