## **Invitation to Bid for Supply and Delivery of Two Hundred Seventy-Two (272) Units of Caliber 5.56mm Assault Rifle**

1. The Bureau of Jail Management and Penology, National Headquarters (BJMP-NHQ), through the 2018 General Appropriations Act intends to apply the sum of stated below being the Approved Budget for the Contract (ABC), hereby invited interested suppliers to bid/negotiate for the herein contract through Alternative Method (Negotiated Procurement), to wit:

2. Pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, we invite legally, technically and financially capable suppliers to negotiate with the BJMP-NHQ on subject requirement.
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from BJMP, Directorates for Logistics and inspect the Bidding Documents at the address given below during 8 AM to 5PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below upon payment of non-refundable fee for the Bidding Documents in the amount stated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.


6. The BJMP-NHQ will hold a Pre-Negotiation Conference on **September 25, 2018 at 10:00 AM at BJMP Main Conference Hall, 144 Mindanao Avenue, Project 8, Quezon City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 9, 2018 at 10:00 AM at BJMP Main Conference Hall, 144 Mindanao Avenue**,

**Project 8, Quezon City.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**

8. Bid opening shall be on **October 9, 2018 at 10:00 AM** at **BJMP Main Conference Hall, 144 Mindanao Avenue, Project 8, Quezon City.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The **BJMP-NHQ** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
