BIDS AND AWARDS COMMITTEE RESOLUTION No. G-2019-002

A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF FOURTEEN (14) UNITS OF BJMP TRANSPORT VEHICLES TO INDUSTRIAL AND TRANSPORT EQUIPMENT (INTECO)

WHEREAS, the Bids and Awards Committee (BAC) of the Bureau of Jail Management and Penology-National Headquarters was created pursuant to Office Order No. 2018-1534 dated December 3, 2018, ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act No. 9184 and its Implementing Rules and Regulations (IRR), and that all procurement are conducted strictly according to specifications;

WHEREAS, on July 30, 2018, DBM Circular Letter No. 2018-8 was issued prescribing guidelines on the conduct of early procurement for FY 2019 National Expenditure Program (NEP);

WHEREAS, the "Supply and Delivery of 14 units of BJMP Transport Vehicles (BTV)" has been included in the Approved Indicative Annual Procurement Plan (APP) for FY 2019 of the BJMP National Headquarters with an Approved Budget for the Contract amounting to Twenty Two Million Pesos (Php22,000,000.00);

WHEREAS, on November 6, 2018, the BJMP-NHQ BAC held a Pre-procurement Conference of the Bureau's procurement project "Supply and Delivery of 14 units of BTV";

WHEREAS, on November 8, 2018, the Invitation to Bid (ITB) for BJMP ITB No. G-2019-003 "Supply and Delivery of 14 units of BTV", was posted at PhilGEPS, BJMP Website as well as in the Bureau's Bulletin Board;

WHEREAS, a pre-bid conference was conducted on November 15, 2018, at the BJMP-NHQ with three (3) prospective bidder¹ in attendance;

WHEREAS, on November 27, 2018, only one (1) bidder² submitted its bid before the 11:30AM deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG). After evaluation of eligibility and technical documents of Industrial and Transport Equipment, Inc. the BAC declared the lone bidder as "eligible". Thus, Envelope No. 2 containing its financial proposal was opened, to wit;

WHEREAS, the TWG conducted post qualification proceedings pursuant to Notice to Bidder issued by the BAC on November 28, 2018, to Industrial and Transport Equipment, Inc. being the Single Calculated Bid for the project. After careful examination on the lowest calculated bidder's eligibility, technical post-qualification and financial documents, the TWG determined that Industrial and Transport Equipment, Inc. complied with the requirements and conditions for eligibility;
