BIDS AND AWARDS COMMITTEE RESOLUTION No. G-2018-030

A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF LOT 1: SUPPLY AND DELIVERY OF 12 GAUGE SHOT SHELL (10,000 RDS) AND LOT 2: SUPPLY AND DELIVERY OF 12 GUAGE RUBBER BULLET (17,750 RDS) TO ARMSCOR SHOOTING CENTER, INC.

WHEREAS, the Bids and Awards Committee (BAC) of the Bureau of Jail Management and Penology-National Headquarters was created pursuant to Office Order No. 2018-1534 dated December 3, 2018, ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act No. 9184 and its Implementing Rules and Regulations (IRR), and that all procurement are conducted strictly according to specifications;

WHEREAS, on August 8, 2018, the BJMP-NHQ BAC held a Pre-Procurement Conference of the Bureau's procurement project "Lot 1: Supply and Delivery of 12 Gauge Shot Shell (10,000 rds) and Lot 2: Supply and Delivery of 12 Gauge Rubber Bullet (17,750 rds)";

WHEREAS, on November 7, 2018, the Invitation to Bid (ITB) for BJMP ITB Reference No. G-2018-013 (Re-bid) and G-2018-014 (Re-bid): Lot 1: Supply and Delivery of 12 Gauge Shot Shell (10,000 rds) and Lot 2: Supply and Delivery of 12 Gauge Rubber Bullet (17,750 rds) respectively, was posted at PhilGEPS, BJMP Website as well as in the Bureau's Bulletin Board;

WHEREAS a pre-bid conference was conducted on November 15, 2018, 10:00 AM at the BJMP-NHQ;

WHEREAS, on November 27, 2018, a lone bidder¹ submitted a bid before the 10:00 AM deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG). After evaluation of eligibility of the Armscor Shooting Center Inc., the BAC declared the lone bidder as "eligible". Thus, Envelope No. 2 containing the financial proposals were opened, to wit;

WHEREAS, the TWG conducted the necessary post qualification proceedings pursuant to Notice to Bidder issued by the BAC on November 28, 2018, to the Armscor Shooting Center Inc., having the Single Calculated Bid for the project. After careful examination on the single calculated bidder's eligibility, technical and post-qualification documents, the TWG determined that the Armscor Shooting Center Inc. complied with the BJMP technical specifications² and is responsive to the legal requirements and conditions for eligibility³;

NOW, THEREFORE, the undersigned members of the Bids and Awards Committee hereby RESOLVE and RECOMMEND for approval of the award of contract for Lot 1: Supply and Delivery of 12 Gauge Shot Shell (10,000 rds) and Lot 2: Supply and Delivery of 12 Gauge Rubber Bullet (17,750 rds) to Armscor Shooting Center Inc. having submitted the Lowest Calculated and Responsive Bid of Php 258,000.00 for the Lot 1: Supply and Delivery of 12 Gauge Shot Shell (10,000 rds) and Php 1,597,500.00 for the Lot 2: Supply and Delivery of 12 Gauge Rubber Bullet (17,750 rds) subject to the posting of a bond to guarantee performance.
