**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 2 UNITS OF BJMP TRANSPORT VEHICLES TO INDUSTRIAL AND TRANSPORT EQUIPMENT INC. (INTECO)**

**WHEREAS**, the Battle of Marawi, also known as the Marawi Siege in 2017, devastated the whole city of Marawi;

**WHEREAS**, Marawi City Jail was one of the facilities that have been destroyed, including all its equipment (i.e. firearms, vehicles, etc.);

**WHEREAS**, through Special Allotment Release Order No. SARO-BMB-D-180019072, the BJMP was allotted funds amounting to Five Million Four Hundred Twenty-Two Thousand Pesos (Php 5,422,000.00) through RA 10964 of the General Appropriations Act FY 2018: National Disaster Risk Reduction and Management Fund (Calamity Fund) to support the implementation of projects, programs and activities (PPAs) of the BJMP in connection with the Marawi Rehabilitation and Recovery Program;

**WHEREAS**, part of the said allotment is intended for the procurement of two (2) units of BJMP Transport Vehicles (BTV) amounting to Three Million Two Hundred Thousand Pesos (Php 3,200,000.00);

**WHEREAS**, through BAC Resolution No. G-2018-020 dated October 24, 2018, the BAC recommended to the Chief, BJMP to resort to Negotiated Procurement – Emergency Cases the Supply and Delivery of 2 Units of BTV and its inclusion to the Supplemental Annual Procurement Plan FY 2018 which was subsequently approved by the C, BJMP;

**WHEREAS**, the Invitation to Bid (ITB) for the above-mentioned project under Bid Reference No. G-2018-015 was published in PhilGEPS, BJMP Website, and BJMP Bulletin Board to invite four (4) Suppliers of known qualification to undertake the project;

**WHEREAS**, a pre-negotiation conference was conducted by the BAC on November 14, 2018, which was attended by two (2) prospective bidders<sup>1</sup>;

**WHEREAS**, Industrial and Transport Equipment Inc. bought the bidding documents and on November 16, 2018 - the scheduled opening of bids, dropped and submitted its bid proposal for the Supply and Delivery of 2 units BTV;

**WHEREAS**, during the bid opening, Industrial and Transport Equipment Inc. passed the non-discretionary pass-fail eligibility criteria and was declared eligible;

**WHEREAS**, below is the result of the opening and evaluation of the lone bidder's financial proposal:
