## INVITATION TO BID FOR SUPPLY AND DELIVERY OF VARIOUS ICT EQUIPMENT

1. The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP)**, through the **GENERAL APPROPRIATIONS ACT FY 2019** intends to apply the following being the Approved Budget for the Contract (ABC) to payments under the following contracts.

Bidders should have completed, within **5 YEARS** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from **BJMP, Directorate for Logistics** and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **September 18, 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount Stated in Paragraph 1.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **BJMP** will hold a Pre-Bid Conference on **September 25, 2019 at 10:00 AM at BJMP Main Conference Hall, 144 Mindanao Avenue, Project 8, Quezon City** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 8, 2019 at 10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **BJMP at BJMP Main Conference Hall, 144 Mindanao Avenue, Project 8, Quezon City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **BJMP** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
