A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 150 UNITS OF NON-CONTACT INFRARED THERMOMETER

WHEREAS, BJMP has set aside funds, as an approved Budget for the Contract (ABC), amounting to Four Hundred Fifty Thousand Pesos (Php 450,000.00) for the Supply and Delivery of 150 Units of Non-Contact Infrared Thermometer;

WHEREAS, the aforementioned project will be procured through Negotiated – Emergency Procurement as indicated in the Supplemental Annual Procurement Plan (APP) FY 2020;

WHEREAS, the BAC in accordance with the provisions of RA 9184 and its Revised IRR prepared and posted the Request for Quotation (RFQ) to the BJMP-NHQ Bulletin Board, PhilGEPS and BJMP Website;

WHEREAS, in response to said advertisements that encourages all technically, legally and financially capable supplier to participate with equal opportunity, Mendo Enterprises and Ormin Pharmaceutical Distribution submitted their quotation;

WHEREAS, all submitted quotations were evaluated and below is the result:
