## A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 15,625 RDS OF SHOT SHELL 12 GAUGE BUCK"00" TO ARMSCOR SHOOTING CENTER INC.

WHEREAS, the Bureau of Jail Management and Penology – National Headquarters (BJMP-NHQ) has posted the bid for the Supply and Delivery of Various Ammunition, Lot 1: Supply and Delivery of 77,922 rds of Cartridge 9mm, Lot 2: Supply and Delivery of 84,533 rds of Cartridge 5.56mm, and Lot 3: Supply and Delivery of 15,625 rds of Shot Shell 12 Gauge Buck "00" with the following Approved Budget for the Contract (ABC):

**WHEREAS**, the Bids and Awards Committee (BAC) conducted a pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS**, the BAC, through its Secretariat, posted the Invitation to Bid (IB) on June 30, 2020 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS**, a pre-bid conference for the above project was conducted on July 7, 2020 wherein the documentary and technical requirements of the project were presented by the BAC and various questions from the prospective bidders were addressed;

**WHEREAS**, in response to the posted IB, Armscor Shooting Center Inc. bought the bidding documents for the Supply and Delivery of 15,625 rds of Shot Shell 12 Gauge Buck "00":

**WHEREAS**, on submission and opening of bid held on July 27, 2020, the abovementioned bidder submitted the required eligibility and technical documents for the project and was found to be "eligible", thus the financial proposal was opened and likewise found to be compliant.
