

## **PROCUREMENT CONTRACT**

**G-018-2021**

THIS AGREEMENT made on the 12 AUG 2021 day of \_\_\_\_\_ 2021 between the **BUREAU OF JAIL MANAGEMENT AND PENOLOGY**, of the Philippines (hereinafter called "the ENTITY") of the one part and **COMWORKS, INC.** of the City of Quezon, Philippines (hereinafter called "the SUPPLIER") of the other part;

WHEREAS, the ENTITY invited Bids for certain goods and ancillary services, particularly the **"Provision of Additional Network Connectivity for Various Offices of BJMP-NHQ"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Nine Pesos and 99/100 (P999,999.99)** (hereinafter called "the CONTRACT PRICE").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Nine Pesos and 99/100 (P999,999.99)** or such other sums as may be ascertained, **COMWORKS, INC.** agrees to the

full completion of the project **“Provision of Additional Network Connectivity for Various Offices of BJMP-NHQ”** for a period of **ninety (90) calendar days** in accordance with his/her/its Bid.

4. The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


