**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION AND TESTING OF REGIONAL JAIL SERVICE INTELLIGENCE OPERATIONS CENTER BJMP RO XIII TO COMWORKS, INC. - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE)**

**WHEREAS**, the Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted a bid for the Internet Service Provider for BJMP NHQ with an Approved Budget for the Contract (ABC) amounting to Twenty-Nine Million Three Hundred Fourteen Thousand Six Hundred Sixty-Nine Pesos and Sixteen Centavos (Php 29,314,669.16);

**WHEREAS**, the BJMP-NHQ BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS**, the BAC, through its Secretariat, posted the Invitation to Bid (IB) on September 9, 2021 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS**, in response to the posted IB, COMWORKS, INC - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE) purchased bidding documents for the above-mentioned project;

**WHEREAS**, during the submission and opening of bids held on October 1, 2021, the required eligibility and technical documents for the project submitted by COMWORKS, INC - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE) was found to be ELIGIBLE, thus the financial proposal was subsequently opened and was likewise found to be compliant. Below is the summary of its bid:

**WHEREAS**, after the Bid Evaluation, it was found that the Computed Bid amount of the bidder is the same with the Bid as Read. Thus, COMWORKS, INC - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE) was declared as the Single Lowest Calculated Bidder;

**WHEREAS**, after careful examination, validation and verification of the Technical Working Group (TWG) of the bid proposal submitted by COMWORKS, INC - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE), it has been found "responsive" as stated in the Bidders Post Qualification Report and Technical Evaluation Report of the TWG;


**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation to declare the proposal submitted by the COMWORKS, INC - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE) for the above-mentioned project, as responsive and eligible for the above-mentioned project;



**NOW THEREFORE**, considering the above premises, **THE BJMP-NHQ BAC RESOLVES AS IT IS HEREBY RESOLVED**, to recommend to the Chief, BJMP the award of contract for the Supply, Delivery, Installation, Configuration and Testing of Regional Jail Service Intelligence Operations Center BJMP RO XIII to COMWORKS, INC - INFINITECARE TECHNOLOGY SOLUTIONS INC (JOINT VENTURE) in the total amount of Twenty-Three Million Pesos (Php 23,000,000.00).
