WHEREAS, President Rodrigo Roa Duterte declared a State of Calamity throughout the Philippines from September 13, 2020 to September 12, 2021 through Proclamation 1021 series of 2020;

WHEREAS, in response to the current State of Calamity due to COVID 19, the BJMP-NHQ intends to procure COVID 19 Antigen Test Machines and Kits;

WHEREAS, the BAC negotiated directly with a legally, technically and financially capable supplier in the name of Vitaline Healthcare Inc;

WHEREAS, the offer of Vitaline Healthcare Inc. was found to be responsive and compliant with the requirements set forth for the project;
