**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND TESTING OF JAIL SERVICE DIGITAL COMMUNICATIONS SYSTEM FOR REGION VI TO RADIONET SOLUTIONS PHILIPPINES INC.**

**WHEREAS**, the Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted a bid for the Supply, Delivery, Installation, Commissioning and Testing of Jail Service Digital Communications System for Region VI with an Approved Budget for the Contract (ABC) amounting Forty Million Pesos (Php 40,000,000.00);

**WHEREAS**, the BAC, through its Secretariat, posted the Invitation to Bid (IB) on November 19, 2020 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS**, a Pre-Bid Conference for the above project was conducted on November 27, 2020 wherein the documentary and technical requirements of the project were presented by the BAC and various questions from the prospective bidders were addressed;

**WHEREAS**, in response to the posted IB, Radionet Solutions Philippines Inc. submitted its bid for the abovementioned project;

**WHEREAS**, during the submission and opening of bids held on December 9, 2020, the required eligibility and technical documents for the project submitted by of Radionet Solutions Philippines Inc. was *rated "Passed"*. Hence, its financial proposal was subsequently opened and was likewise found to be compliant. Below is the summary of the bid:

**WHEREAS**, after the Bid Evaluation, it was found that the bid as computed of Radionet Solutions Philippines Inc. amounted to Thirty-Eight Million Eight Hundred Ninety-Six Thousand Seven Hundred Eighty-Five Pesos and 71/100 (Php 38,896,785.71). Thus, Radionet Solutions Philippines Inc. was declared as the Single Calculated Bidder;

**WHEREAS**, after careful examination, validation and verification of the Technical Working Group (TWG) of the bid proposal submitted by the Single Calculated Bidder, by Radionet Solutions Philippines Inc., it has been found "Responsive" as stated in the Bidders Post Qualification Report and Technical Evaluation Report of the TWG;

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation to declare Radionet Solutions Philippines Inc. as the Single Calculated and Responsive Bidder for the abovementioned project;

**NOW THEREFORE**, considering the above premises, **THE BJMP-NHQ BAC RESOLVES, AS IT IS HEREBY RESOLVED**, to recommend to the Chief, BJMP the award of Contract for the Supply, Delivery, Installation, Commissioning and Testing of Jail Service Digital Communications System for Region VI to Radionet Solutions

Philippines Inc. in the total amount of Thirty-Eight Million Eight Hundred Ninety-Six Thousand Seven Hundred Eighty-Five Pesos and 71/100 (Php 38,896,785.71).
