**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE  
SUPPLY AND DELIVERY OF DESKTOP COMPUTER (REBID) TO COLUMBIA  
TECHNOLOGIES INC.**

**WHEREAS**, Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted an Invitation to Bid (IB) for the Supply and Delivery of Desktop Computer (Rebid) with an Approved Budget for the Contract (ABC) amounting to Four Million Five Hundred Three Thousand Four Hundred Seventeen Pesos (Php 4,503,417.00);

**WHEREAS**, the BJMP-NHQ BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS**, the BAC, through its Secretariat, posted the IB on February 26, 2021 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS**, a pre-bid conference for the above project was conducted on March 9, 2021 wherein the documentary and technical requirements of the project were presented by the BAC and various questions from the prospective bidders were addressed;

**WHEREAS**, in response to the posted IB, Columbia Technologies, Inc., Xitrix Computer Corporation and Advance Solutions, Inc. bought the bidding documents for the Supply and Delivery of Desktop Computer (Rebid);

**WHEREAS**, on submission and opening of bids held on March 23, 2021, the abovementioned bidders submitted the required eligibility and technical documents which was found to be “eligible”, thus the financial proposal was opened which was likewise found to be compliant. Below is the summary of the bids:

Columbia Technologies, Inc.	4,338,789.60
Advance Solutions, Inc.	4,382,640.00
Xitrix Computer Corporation	4,400,000.00

**WHEREAS**, after the Bid Evaluation, it was determined that the bid amount as read of the above bidders were also same as their calculated bids. Thus, Columbia Technologies Inc. was declared as the Lowest Calculated Bidder;

**WHEREAS**, Columbia Technologies Inc. was subjected to post-qualification to determine its compliance and responsiveness to all requirements and conditions specified in the bidding documents;

**WHEREAS**, after careful examination, validation and verification of the TWG of the bid proposal submitted Columbia Technologies Inc., it has been found “Responsive” having complied with the requirements of the Bidding Document;




**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declared Columbia Technologies Inc. as the Lowest Calculated and Responsive Bidder;

**WHEREAS**, Section 12.1(h) of the Revised IRR of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity of his/her duly authorized representative;

**NOW THEREFORE**, for and in consideration of the foregoing, **THE BJMP-NHQ BAC RESOLVES AS IT IS HEREBY RESOLVED** to RECOMMEND to the Chief, BJMP the Award of Contract for the Supply and Delivery of Desktop Computer (Rebid) to Columbia Technologies Inc.

**UNANIMOUSLY APPROVED.**
