**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE  
SUPPLY AND DELIVERY OF UNINTERRUPTIBLE POWER SUPPLY TO  
AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC.**

**WHEREAS**, Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted an Invitation to Bid (IB) for the Supply and Delivery of Uninterruptible Power Supply (Rebid) with an Approved Budget for the Contract (ABC) amounting to Eight Hundred Eighty-Two Thousand Four Hundred Sixty-Seven Pesos (Php 882,467.00);

**WHEREAS**, the BJMP-NHQ BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS**, the BAC, through its Secretariat, posted the IB on February 27, 2021 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS**, in response to the posted IB, LSI Leading Technologies, Inc. and Automation Specialists and Power Exponents Inc. bought the bidding documents for the Supply and Delivery of Uninterruptible Power Supply (Rebid);

**WHEREAS**, on submission and opening of bids held on March 10, 2021, the abovementioned bidders submitted the required eligibility and technical documents which was found to be “eligible”, thus the financial proposal was opened which was likewise found to be compliant. Below is the summary of the bids:

LSI Leading Technologies, Inc.	564,563.32
Automation Specialists and Power Exponents Inc.	568,740.00

**WHEREAS**, after the Bid Evaluation, it was determined that the bid amount as read of the above bidders were also same as their calculated bids. Thus, LSI Leading Technologies, Inc. was declared as the Lowest Calculated Bidder;

**WHEREAS**, LSI Leading Technologies, Inc. was subjected to post-qualification to determine its compliance and responsiveness to all requirements and conditions specified in the bidding documents;

**WHEREAS**, after careful examination, validation and verification of the TWG of the bid proposal submitted by LSI Leading Technologies, Inc., it has been found “Non-Responsive” due to the following grounds:

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declared LSI Leading Technologies, Inc. as Post Disqualified for the project;

**WHEREAS**, Automation Specialist and Power Exponents, Inc. was subjected to post-qualification to determine its compliance and responsiveness to all requirements and conditions specified in the bidding documents;

**WHEREAS**, after careful examination, validation and verification of the TWG of the bid proposal submitted by Automation Specialist and Power Exponents, Inc., it has been found "Responsive" having complied with the requirements of the Bidding Document;


**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWGs recommendation and declared Automation Specialist and Power Exponents, Inc. as the Lowest Calculated and Responsive Bidder;

**WHEREAS**, Section 12.1(h) of the Revised IRR of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity of his/her duly authorized representative;

**NOW THEREFORE**, for and in consideration of the foregoing, **THE BJMP-NHQ BAC RESOLVES AS IT IS HEREBY RESOLVED** to RECOMMEND to the Chief, BJMP the Award of Contract of Supply and Delivery of Uninterruptible Power Supply (Rebid) to Automation Specialist and Power Exponents, Inc.
