**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF  
CONTRACT FOR THE SUPPLY AND DELIVERY OF 14 UNITS OF  
BJMP TRANSPORT VEHICLES TO INDUSTRIAL & TRANSPORT EQUIPMENT, INC**

**WHEREAS**, Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted the first bid for the Supply and Delivery of 14 Units of BJMP Transport Vehicles with an Approved Budget for the Contract (ABC) amounting to Twenty-Two Million Pesos (Php 22,000,000.00);

**WHEREAS**, the BJMP-NHQ BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS**, the BAC, through its Secretariat, posted the Invitation to Bid (IB) on January 7, 2021 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS**, a pre-bid conference for the above project was conducted on January 15, 2021 wherein the documentary and technical requirements of the project were presented by the BAC and various questions from the prospective bidders were addressed;

**WHEREAS**, in response to the posted IB, INDUSTRIAL & TRANSPORT EQUIPMENT, INC and AREZA MOTOR SALES purchased bidding documents for the abovementioned project;

**WHEREAS**, during the submission and opening of bids held on January 28, 2021, the required eligibility and technical documents for the project submitted by INDUSTRIAL & TRANSPORT EQUIPMENT, INC AND AREZA MOTOR SALES were found to be ELIGIBLE, thus its financial proposal was subsequently opened and was likewise found to be compliant. Below is the summary of the bid:

**WHEREAS**, after the Bid Evaluation, it was found that the Computed Bid amount of bidder is the same with the Bid as Read. Thus, AREZA MOTOR SALES was declared as the Lowest Calculated Bidder;

**WHEREAS**, after careful examination, validation and verification of the Technical Working Group (TWG) of the bid proposal submitted by AREZA MOTOR SALES, it has been found “non-responsive” as stated in the Bidders Post Qualification Report and Technical Evaluation Report of the TWG;

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation to declare AREZA MOTOR SALES as non-responsive and Ineligible for the abovementioned project;

**WHEREAS**, after careful examination, validation and verification of the TWG of the bid proposal submitted by the Second Lowest Calculated Bidder, INDUSTRIAL &

TRANSPORT EQUIPMENT, INC, it has been found "Responsive" as stated in the Bidders Post Qualification Report and Technical Evaluation Report of the TWG;


**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation to declare INDUSTRIAL & TRANSPORT EQUIPMENT, INC as responsive and eligible for the abovementioned project;

**NOW THEREFORE**, considering the above premises, **THE BJMP-NHQ BAC RESOLVES AS IT IS HEREBY RESOLVED** to declare INDUSTRIAL & TRANSPORT EQUIPMENT, INC eligible for the abovementioned project.

**UNANIMOUSLY APPROVED.**
