**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF
CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS ICT EQUIPMENT
LOT 3: SUPPLY AND DELIVERY OF EXECUTIVE LAPTOP TO PRONET SYSTEMS
INTEGRATED NETWORK SOLUTIONS INC**

WHEREAS, the Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted a bid for the Supply and Delivery of Various ICT Equipment Lot 3: Supply and Delivery of Executive Laptop with an Approved Budget for the Contract (ABC) amounting to Five Million Six Hundred One Thousand Three Hundred Forty Pesos (Php 5,601,340.00);

WHEREAS, the BJMP-NHQ BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

WHEREAS, the BAC, through its Secretariat, posted the Invitation to Bid (IB) on September 9, 2021 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

WHEREAS, in response to the posted IB, PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC and MASANGKAY COMPUTER CENTER purchased bidding documents for the above-mentioned project;

WHEREAS, during the submission and opening of bids held on September 17, 2021, the required eligibility and technical documents for the project submitted by PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC and MASANGKAY COMPUTER CENTER were found to be ELIGIBLE, thus the financial proposal was subsequently opened and were likewise found to be compliant. Below is the summary of their respective bids:

MASANGKAY COMPUTER CENTER	5,600,000.00

WHEREAS, after the Bid Evaluation, it was found that the Computed Bid amount of the bidders are the same with the Bid as Read. Thus, PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC was declared as the Lowest Calculated Bidder;


WHEREAS, after careful examination, validation and verification of the Technical Working Group (TWG) of the bid proposal submitted by PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC, it has been found “responsive” as stated in the Bidders Post Qualification Report and Technical Evaluation Report of the TWG;

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation to declare the proposal submitted by the PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC for the above-mentioned project, as responsive and eligible for the above-mentioned project;

NOW THEREFORE, considering the above premises, **THE BJMP-NHQ BAC RESOLVES AS IT IS HEREBY RESOLVED**, to declare PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC eligible for the above-mentioned project.
