Clarifications:

1. *Technical Specs: HDD Supports at least 4 HDD bay or equivalent number for the required storage capacity.*

Let it be clarified that the statement HDD supports at least 4HDD bay or equivalent number for the required storage capacity is the minimum number of bay and equivalent number refers to the equivalent number of HDD total capacity. Example, the total capacity of 10 pcs 8 TB HDD is 80TB or equivalent to 8 pcs 10 TB HDD, hence the NVR should able to accommodate this number of equivalent HDD capacity.

2. *Since the technical specification indicates that the minimum should be 4 HDD bay or equivalent number for required storage capacity, can we disregard the 16xbay that is indicated in the summary?*

The specified number of bays referred to items 7, 8, and 9 of the Bill of Quantities (BOQ) with respect to the Technical Specifications are dependent on the total HDD storage capacity requirement indicated in Item No. 10 (indicated in this Bid Bulletin) of the BOQ is dependent on the total storage capacity of HDD but not on the number of HDD. Thus, the bidders may offer higher storage capacity but a lesser number of HDD provided they comply with the retention of a minimum of 60 days video recording at 25fps to 30fps, at least 3MP resolution, with permanent recording motion detection or the total required storage capacity, whichever is higher.

3. *How many days is the required retention for the NVR?*

Minimum of 60 days video recording at 25fps to 30fps, at least 3MP resolution, with permanent recording motion detection or the total required storage capacity, whichever is higher.

4. *For Jail Unit Monitor: Physical Bezel Color: Black or Dark Color; Bezel with: $\geq 11.9\text{mm}$ (T/R/L), $\geq 18\text{mm}$ (B) – thinner bezel is better. Can we propose for thinner bezel instead?*

Yes. The thinner the bezel, the better.

This Bid Bulletin No. 1 shall form part of the Bidding Documents. Any provision in the issued bid documents inconsistent herewith is hereby amended, modified and superseded accordingly.
