3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

A complete set of Bidding Documents may be acquired by interested Bidders on **September 9, 2021** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount **INDICATED IN PARA 1**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The **BJMP-NHQ** will hold a Pre-Bid Conference on **September 17, 2021 at 2:00 PM** through video conferencing or webcasting *via ZOOM (Meeting ID: 883 8121 3005 and Password: 414559)*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat **MANUALLY** at the **BJMP-NHQ, 1<sup>ST</sup> FLOOR, MESSAGE CENTER, 144 MINDANAO AVENUE PROJECT 8, QUEZON CITY**, on or before **October 1, 2021 at 2:00 PM**. Late bids shall not be accepted.
