**INVITATION TO BID FOR SUPPLY, DELIVERY, INSTALLATION,
CONFIGURATION AND TESTING OF REGIONAL JAIL SERVICE
INTELLIGENCE OPERATIONS CENTER BJMP RO XIII**

1. The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY – NATIONAL HEADQUARTERS (BJMP-NHQ)**, through the **GENERAL APPROPRIATIONS ACT FOR FY 2021** intends to apply the sum of **TWENTY- NINE MILLION THREE HUNDRED FOURTEEN THOUSAND SIX HUNDRED SIXTY-NINE PESOS AND SIXTEEN CENTAVOS (PHP 29,314,669.16)** being the ABC to payments under the contract for **BJMP REFERENCE NO. G-2021-013**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **BJMP-NHQ** now invites bids for the above Procurement Project. Contract duration is **135 CALENDAR DAYS UPON RECEIPT OF NTP**. Bidders should have completed, within **FIVE (5) YEARS FROM THE DATE OF SUBMISSION AND RECEIPT OF BIDS**, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from **BJMP – DIRECTORATE FOR LOGISTICS** and inspect the Bidding Documents at the address given below on weekdays from 8 AM to 5 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **September 9, 2021** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TWENTY-FIVE THOUSAND PESOS (PHP 25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The **BJMP-NHQ** will hold a Pre-Bid Conference on **September 17, 2021 at 11:00 AM** through video conferencing or webcasting *via ZOOM (Meeting ID: 883 8121 3005 and Password: 414559)*, which shall be open to prospective bidders.


7. Bids must be duly received by the BAC Secretariat **MANUALLY** at the **BJMP-NHQ, 1ST FLOOR, MESSAGE CENTER, 144 MINDANAO AVENUE PROJECT 8, QUEZON CITY**, on or before **October 1, 2021 at 11:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **October 1, 2021 at 11:00 AM** via **ZOOM (Meeting ID: 835 8780 7508 and Password: 601606)**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **BJMP-NHQ** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
