## BIDS AND AWARDS COMMITTEE Resolution No. G-2022-019

## A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS AMMUNITIONS (RE-BID) LOT 2: SUPPLY AND DELIVERY OF CARTRIDGE 5.56MM TO TRUST TRADE

**WHEREAS,** the Bureau of Jail Management and Penology – National Headquarters Bids and Awards Committee (BJMP-NHQ BAC) has posted a bid for the Supply and Delivery of Various Ammunitions (Re-Bid) Lot 2: Supply and Delivery of Cartridge 5.56mm with an Approved Budget for the Contract (ABC) amounting to One Million Four Hundred Eighty-One Thousand Two Hundred Twenty Pesos (Php 1,481,220.00);

**WHEREAS,** the BJMP-NHQ BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS,** the BAC, through its Secretariat, posted the Invitation to Bid (IB) on January 19, 2022 in the Philippine Government Electronic Procurement System (PhilGEPS) website, BJMP Website and BJMP Bulletin Board;

**WHEREAS,** a Pre-bid conference was conducted on January 26, 2022, 1:00 PM via zoom video-conferencing which was attended by two (2) Prospective bidders;

**WHEREAS**, in response to the posted IB, Armscor Shooting Center, Inc. and Trust Trade purchased bidding documents for the above-mentioned project;

**WHEREAS,** during the submission and opening of bids held on February 9, 2022, the required eligibility and technical documents for the project submitted by Armscor Shooting Center, Inc. and Trust Trade were found to be ELIGIBLE, thus the financial proposals were subsequently opened and were likewise found to be compliant. Below is the summary of their respective bids:

TRUST TRADE	1,179,068.00
ARMSCOR SHOOTING CENTER, INC.	1,257,560.00

**WHEREAS**, after the Bid Evaluation, it was found that the Computed Bid amounts of the bidders are the same with the Bids as Read. Thus, TRUST TRADE was declared as the Lowest Calculated Bidder;

**WHEREAS,** after careful examination, validation and verification of the Technical Working Group (TWG) of the bid proposal submitted by TRUST TRADE, it has been found "responsive" as stated in the Bidders Post Qualification Report and Technical Evaluation Report of the TWG;

**WHEREAS,** the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation to declare the proposal submitted by the TRUST TRADE for the above-mentioned project, as responsive and eligible for the above-mentioned project;

**NOW THEREFORE, THE BJMP-NHQ BAC RESOLVES AS IT IS HEREBY RESOLVED,** to recommend to the Chief, BJMP the award of contract to TRUST TRADE for the Supply and Delivery of Various Ammunitions Lot 2: Supply and Delivery of Cartridge 5.56mm in the total amount of One Million One Hundred Seventy-Nine Thousand Sixty-Eight Pesos (Php 1,179,068.00).
