## INVITATION TO BID FOR THE PROCUREMENT OF ONE (1) LOT OF REHABILITATION SUPPLIES 02-2022-10R

1. The *Bureau of Jail Management and Penology Regional Office-CALABARZON (BJMPRO-CALABARZON)*, through *General Appropriations Act (GAA) of the Republic of the Philippines (RA 10633) FY 2022* intends to apply the sum of being the ABC to payments under the contract for *the Procurement of One (1) Lot of Rehabilitation Supplies 02-2022-10R*. Bids received in excess of the ABC shall be *One Million Six Hundred Sixty Thousand Pesos (P1,660,000.00)* automatically rejected at bid opening.

The *BJMPRO-CALABARZON*, through the *General Appropriations Act (GAA) of the Republic of the Philippines (RA 10633) FY 2022* intends to apply the sum of *One Million Six Hundred Sixty Thousand Pesos (P1,660,000.00)* being the ABC to payments under the contract for One (1) Lot of Rehabilitation Supplies 02-2022-10R. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *BJMPRO-CALABARZON* now invites bids for the above Procurement Project. Delivery of the Goods is required by *Five (5) days after the issuance of Notice to Proceed*. Bidders should have completed, within *Two (2) Years*, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

A complete set of Bidding Documents may be acquired by interested Bidders on **August 09, 2022 to August 30, 2022**, from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00).* The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, or through electronic means.*
6. The **BJMPRO-CALABARZON** will hold a Pre-Bid Conference<sup>1</sup> on **August 17, 2022 at 10:00a.m** at **2nd floor Mini-Conference Room, Logistics Division, BJMP Regional Office, Brgy. Turbina, Calamba City, Laguna**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **August 30, 2022, at 10:30a.m.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **August 30, 2022 at 11:00a.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **BJMPRO-CALABARZON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
