Must have built-in man-down features for handheld radio only.

In Term of Reference B. System Features Requirements (Digital Radio System)

Shall support integration and collaboration with JSIOC and/or Regional JSIOC;
 Data and Voice integration for implementing region (Region VII), and voice integration only for other regions.

In Term of Reference B. System Features Requirements (Digital Radio System)

Wider coverage conventional communications system, supports sending broadcast message in case of emergency; **Emergency broadcast requirement at least for Region VII and NHQ.**

In Term of Reference B. System Features Requirements (Digital Radio System) I.2

Digital Two-way Fixed Base and Mobile Radio Stations. Accessories: Fixed-base station enclosure; we require enclosure for the fixed base radio and its power supply, custom-built fabrication (metal enclosure) may be allowed.

In Term of Reference XII. Certifications or Unconditional Statement of Compliance

 The bidder shall have provision for network connectivity for Regional VII Radio Communication Cabinet; Local internet connectivity from the Regional office 7 source of internet.

In Term of Reference: c. Uninterruptible Power Supply (UPS) Output Rated Power: 6KVA and at least 4800W/ 3KVA and at least 2400W; **1** x 6KVA for the Regional Office and $6 \times 3KVA$ for the 6 repeater stations.
