- 4. Award of Contract shall be given to the Lowest Quotation (for goods and infrastructure) or, the highest rated offer (for consulting service) which complies with the minimum technical specification and other terms and conditions stated therein.
- 5. Any interlineations, erasure or overwriting shall be valid only if they are signed or initialed by you or your authorized representative/s.
- 6. The item/s shall be delivered according to requirement specified in the Technical Specifications.
- 7. The BJMP-NHQ shall have the right to inspect and/or to inspect the materials and equipment's to be used to conform with the technical specifications.
