

PROCUREMENT CONTRACT
G-026-2022

THIS AGREEMENT made on the _____ day of NOV 10 2022 2022 between the **BUREAU OF JAIL MANAGEMENT AND PENOLOGY**, of the Philippines (hereinafter called "the ENTITY") of the one part and **MICROGENESIS SOFTWARE INC., DOING BUSINESS UNDER THE NAME AND STYLE OF MICROGENESIS BUSINESS SYSTEMS** of Mandaluyong City, Philippines (hereinafter called "the SUPPLIER") of the other part;

WHEREAS, the ENTITY invited Bids for certain goods and ancillary services, particularly the **"Supply and Delivery of Web Cameras and Headsets (Re-Bid)"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Four Hundred Fifty-Six Thousand Nine-Hundred Ninety-Two Pesos (Php 3,456,992.00)** (hereinafter called "the CONTRACT PRICE").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i.1 Schedule of Requirements;
 - i.2 Technical Specifications;
 - i.3 General and Special Conditions of Contract; and
 - i.4 Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Three Million Four Hundred Fifty-Six Thousand Nine-Hundred Ninety-Two Pesos (Php 3,456,992.00)** or such other sums as may be ascertained, **MICROGENESIS SOFTWARE INC., DOING BUSINESS UNDER THE NAME AND STYLE OF MICROGENESIS BUSINESS SYSTEMS** agrees to the full completion of the project "Supply

and Delivery of Web Cameras and Headsets (Re-Bid)" for a period of **Ninety (90) calendar days** in accordance with his/her/its Bid.

4. In order to assure that manufacturing defects shall be corrected by the SUPPLIER, the SUPPLIER **shall post a Warranty Security in the form of Retention Money in an amount equivalent to at least one percent (1%) of every progress payment, or a Special Bank Guarantee equivalent to at least one percent (1%) of the total contract price, within seven (7) calendar days upon acceptance of delivery by the ENTITY.** The said amount shall only be released after the lapse of the warranty period. Provided, however, that the goods delivered are free from patent and latent defects and all conditions imposed under the Contract have been fully met.
5. The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
