**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PLAQUES, SASH, MEDALS AND PINS FOR THE GAWAD PENOLOHIYA 2022: LOT 2 TO DVK PHILIPPINES ENTERPRISES**

**WHEREAS**, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act," took effect on January 26, 2003, while its 2016 Revised Implementing Rules and Regulations (RIRR) took effect on October 28, 2016;

**WHEREAS**, RA 9184 provides that it is a declared policy of the Government of the Philippines (GoP) to promote good governance and to adhere to the principles of transparency, accountability, equity, efficiency, and economy in its procurement process;

**WHEREAS**, Section 2 of the 2016 RIRR of RA 9184 states that it is the policy of the GoP that procurement of goods, infrastructure projects and consulting services shall be competitive and transparent, and therefore shall undergo competitive bidding, except provided in Rule XVI of the RIRR;

**WHEREAS**, BJMP has set aside funds, as an Approved Budget for the Contract (ABC), amounting to Ninety-Seven Thousand Five Hundred Pesos (Php 97,500.00) for the Supply and Delivery of Plaques, Sash, Medals and Pins for the Gawad Penolohiya 2022: Lot 2;

**WHEREAS**, the BJMP-NHQ BAC, in accordance with the provisions of RA 9184 and its Revised IRR, prepared and posted the Request for Quotation (RFQ) to the BJMP-NHQ Bulletin Board, PhilGEPS, and BJMP Website and was sent to three (3) suppliers of known qualifications;

**WHEREAS**, in response to said advertisements that encourage all technically, legally and financially capable suppliers to participate with equal opportunity, two (2) companies submitted their quotations;

**WHEREAS**, the submitted quotations were evaluated and below is the result of the evaluation of their Eligibility, Technical, and Financial Requirements:
